Dear Shipmate,

At the June meeting of the Friends of Albacore Committee, the group voted to commission two new items to be added to the Park grounds. The first is a memorial to the first submarine Albacore (SS 218) lost during World War II. This memorial will be placed in the Memorial Garden. The second item is a granite bench dedicated to Joe Sawtelle, one of the prime movers in getting our Albacore out of the Reserve Fleet in Philadelphia and back to Portsmouth. This bench will be located on the west side of the boat under some shade trees across from the sail.

During the August Friends meeting, we met with a representative of the Perry Monument Company to determine a delivery date and to firm up the exact locations for the two Park additions. We also discussed relocating one monument which currently resides inside the fence that surrounds Albacore. The side of the pit in which Albacore rests are eroding and the monument is in danger of falling to the bottom. This monument and the new Sawtelle bench will be located near an existing shipyard donated bench.

Three shipmates have stepped forward and volunteered to take on the planning effort for the next reunion, tentatively set for sometime in 2010. Frank Lyons ('67-'69) from Wayne, NJ, Jerry Sliss ('67-'69) from Poughkeepsie, NY and Jack Snodgrass ('67-'69) from Apex, NC will be pulling things together. Yes, it is a ways off, but it sounds like they are adhering to the seven P's: "Proper Prior Planning Prevents Piss Poor Performance". With two plus years to get things organized, we can expect a fine performance. They are working on a reunion survey to be sent out to all hands sometime after Labor Day. Stay tuned.

Admiral Ross Williams pointed out that Lt. Robert Krag, listed as being on Final Patrol on our website, was lost when the Thresher went down in 1963. Bob is the third former Albacore shipmate, along with John Garner and Wayne Lavoie, lost on Thresher. At the time, Bob was the SubLant representative on Thresher's sea trial.

We have lost contact with Danny Hixson. His snail mail copy of the last newsletter has been returned as undeliverable. Dan and wife Barbara stopped by the boat during our August Friends meeting, And sad to report the

Along the same line, a group from the Heinemann Publishing Company, located in Portsmouth, will be coming aboard on 12 September to hold a field day on Albacore as part of the United Way of Greater Portsmouth’s Fall Day of Caring. If anyone can join us for the day, we will be starting at 0900. Lunch will be provided.
