A MUSEUM BUILDING DISPLAYS ITEMS PECULIAR TO USS ALBACORE, THE U.S. SUBMARINE FORCE IN GENERAL, AND THE LOCAL MARITIME REGION. ATTENDANCE AT THE PARK IN 2025 WAS 37,112 PERSONS.
