THE FORMER USS ALBACORE IS SITUATED IN A DRY BASIN IN ALBACORE PARK WHERE THE GENERAL PUBLIC CAN ENTER AND WALK THROUGH IT, TOUCH AND OPERATE EQUIPMENT, AND LISTEN TO AUDIO EXPLANATIONS AT NUMEROUS LOCATIONS INSIDE AND OUTSIDE THE VESSEL. THERE IS A SMALL MUSEUM BUILDING WITH DISPLAYS RELATING TO THE SUBMARINE'S HISTORY, SUBMARINE DESIGN AND THE PORTSMOUTH NAVAL SHIPYARD. ATTENDANCE AT THE PARK WAS 37,886 VISITORS. A VARITEY OF EDUCATIONAL PROGRAMS FOCUSING ON THE MARITIME ENVIRONMENT OF THE PISCATAQUA RIVER BASIN INCLUDING LECTURES, WORKSHOPS, DEVELOPMENT OF TOOLS FOR STEM EDUCATORS, AND DAY CAMPS WERE CONDUCTED.
